### **Instruction to Bidders**

<b>A. Introduction</b>		
<b>1. Source of Funds</b>	<b>1.1</b>	The Procuring Agency, THQ Hospital Chichawatni intends to apply a portion of its regular Budget to eligible payments under the contract for which this Invitation for Bids are Issued
<b>2. Eligible Bidders</b>	<b>2.1</b>	This Invitation for Bids is open to all suppliers, except as provided hereinafter.
	<b>2.2</b>	Government-owned enterprises may participate only if they are legally and financially autonomous, if they operate under commercial law, and if they are not a dependent agency of the Government
	<b>2.3</b>	Bidders shall not be under a declaration of blacklisting by any Government department or Punjab Procurement Regulatory Authority (PPRA)
<b>3. Cost of Bidding</b>	<b>3.1</b>	The Bidder shall bear all costs associated with the preparation and submission of its bid, and the Procuring Agency named in the Bid Data Sheet, hereinafter referred to as —the Purchaser, will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.
<b>B. The Bidding Documents</b>		
<b>4. Contents Of Bidding Documents</b>	<b>4.1</b>	The Goods required, bidding procedures, and contract terms are prescribed in the bidding documents. In addition to the Invitation for Bids, the bidding documents include:

	<b>4.2</b>	The Bidder is expected to examine all instructions, forms, terms, and specifications in the bidding documents. Failure to furnish all information required by the bidding documents or to submit a bid not substantially responsive to the bidding documents in every respect will be at the Bidder's risk and may result in the rejection of its bid.
<b>5. Clarification Of Bidding Documents</b>	<b>5.1</b>	A prospective Bidder requiring any clarification of the bidding documents may notify the Purchaser in writing or by email at the will respond in writing to any request for clarification of the Purchaser's address indicated in ITB Clause 1.4. The Purchaser bidding documents which it receives no later than three (3) days prior to the deadline for the submission of bids prescribed in the Bid Data Sheet. (including an explanation of the query but without identifying the source of inquiry). Written copies of the Purchaser's response will be sent to all prospective bidders that have received the bidding documents.
<b>6. Amendment of Bidding Documents</b>	<b>6.1</b>	At any time prior to the deadline for submission of bids, the Purchaser, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, may modify the bidding documents by amendment.
	<b>6.2</b>	All prospective bidders that have received the bidding documents will be notified of the amendment in writing or by email, and will be bidding on them.
	<b>6.3</b>	In order to allow prospective bidders reasonable time in which to take the amendment into account in preparing their bids, the Purchaser, at its discretion, may extend the deadline for the submission of bids.

<b>C. Preparation of Bids</b>		
<b>7. Language of Bid</b>	<b>7.1</b>	The bid prepared by the Bidder, as well as all correspondence and documents relating to the bid exchanged by the Bidder and the Purchaser shall be written in the language specified in the Bid Data Sheet. Supporting documents and printed literature furnished by the Bidder may be in same language.
<b>8. Documents Comprising Bid</b>	<b>8.1</b>	The bid prepared by the Bidder shall comprise the following Components:
		(a) a Bid Form and a Price Schedule completed completely.
		(b) documentary evidence established in accordance with ITB Clause 13 that the Bidder is eligible to bid and is qualified to perform the contract if its bid is accepted;
		(c) documentary evidence established that goods to be supplied by the Bidder are eligible and conform to the bidding documents; and
		(d) bid security furnished in accordance with ITB Clause 4.1.
<b>9. Bid Form</b>	<b>9.1</b>	The Bidder shall complete the Bid Form and the appropriate Price Schedule furnished in the bidding documents, indicating the Goods to be supplied, a brief description of the Goods, and their quantity, and prices.
<b>10. Bid Prices</b>	<b>10.1</b>	The Bidder shall indicate on the appropriate Price Schedule the unit prices (where applicable) and total bid price of Goods it proposes to supply under the contract.
	<b>10.2</b>	Prices indicated on the Price Schedule shall be <b>delivered duty paid (DDP) prices</b> .
	<b>10.3</b>	The Bidder's separation of price components will be solely for the purpose of facilitating the comparison of bids by the Purchaser and will not in any way limit the Purchaser's right to contract on any of the terms offered.
	<b>10.4</b>	Prices quoted by the Bidder shall be fixed during the Bidder's performance of the contract and not subject to variation on any account, unless otherwise specified in the Bid Data Sheet. A bid submitted with an <b>adjustable price quotation</b> will be treated as nonresponsive and will be rejected.

<b>11. Bid Currencies</b>	<b>11.1</b>	Prices shall be quoted in <b>Pak Rupees</b> unless otherwise specified in the Bid Data Sheet.
<b>12. Documents Establishing Bidder's Eligibility and Qualification</b>	<b>12.1</b>	The Bidder shall furnish, as part of its bid, documents establishing the Bidder's eligibility to bid and its qualifications to perform the contract if its bid is accepted.
	<b>12.2</b>	The documentary evidence of the Bidder's eligibility to establish to the Purchaser's satisfaction that the Bidder, at the bid shall time of submission of its bid, is eligible as defined under ITB Clause 3.1 and 3.2.
	<b>12.3</b>	The documentary evidence of the Bidder's qualifications to perform the contract if its bid is accepted shall establish to the Purchaser's Satisfaction:
		(a) that, in the case of a Bidder offering to supply Goods under the contract which the Bidder did not manufacture or otherwise produce, the Bidder hold a valid licence & authorization to supply Goods in Pakistan;
		(b) that the Bidder has the financial, technical, and production capability necessary to perform the contract.
<b>13. Documents Establishing Goods' Eligibility and Conformity To Bidding Documents</b>	<b>13.1</b>	The Bidder shall furnish, as part of its bid, documents establishing the eligibility and conformity to the bid, documents establishing the eligibility and conformity to supply under the contract.
	<b>13.2</b>	The documentary evidence of the conformity of Goods to the bidding documents may be in the form of literature, drawings and data and shall consist of:
		(a) a detailed description of the essential technical and other characteristics of Goods;
		(b) a list giving full particulars, including available sources and current prices of Goods or a period to be specified in the Bid Data Sheet, following commencement of the use of Goods by the Purchaser; and

		(c) an item-by-item commentary on the Purchaser's Technical Specifications demonstrating substantial responsiveness of the Goods to those specifications, or a statement of deviations and exceptions to the provisions of The Technical Specifications
<b>14. Bid Security</b>	<b>14.1</b>	Pursuant to ITB Clause 4.1, the Bidder shall furnish, as part of its bid, a bid security in the amount specified in the Bid Data Sheet.
	<b>14.2</b>	The bid security is required to protect the Purchaser against the risk of Bidder's conduct which would warrant the security's forfeiture.
	<b>14.3</b>	The bid security shall be in Pak. Rupees and shall be in one of the following forms:
		(a) Bank call-deposit (CDR)/Demand Draft (DD)/Pay Order (PO) valid for thirty (30) days beyond the validity of bid.
	<b>14.4</b>	Any bid not secured in accordance with ITB Clauses 4.1 will be rejected by the Purchaser as nonresponsive.
	<b>14.5</b>	Unsuccessful bidders' bid security will be discharged or returned as promptly as possible but not later than thirty (30) days after the expiration of the period of bid validity.
	<b>14.6</b>	The successful Bidder's bid security will be discharged upon the Bidder signing the contract, and furnishing the performance security.
	<b>14.7</b>	The bid security may be forfeited:
		(a) if a Bidder withdraws its bid during the period of bid validity specified by the Bidder on the Bid Form; or
		(b) in the case of a successful Bidder, if the Bidder fails:
	(i) to sign the contract in accordance; or	
	(ii) to furnish Performance Guarantee.	
<b>15. Period Of Validity Of Bids</b>	<b>15.1</b>	Bids shall remain valid for the period specified in the Bid Data Sheet after the date of bid opening prescribed by the Purchaser, as mentioned in ITB Clause 4.3. A bid valid for a shorter period shall be rejected by the Purchaser as nonresponsive.

	<b>15.2</b>	In Exceptional Circumstances, the purchaser may solicit the Bidder's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing (or by email). A Bidder may refuse the request without forfeiting its bid security.
	<b>15.3</b>	In the case of fixed price contracts, if the award is delayed by a period exceeding sixty (60) days beyond the expiry of the initial bid validity, the contract price will be adjusted by a factor specified in the request for extension.
<b>16.Format and Signing Of Bid</b>	<b>16.1</b>	The Bidder shall prepare an original and the number of copies of the bid indicated in the Bid Data Sheet, clearly marking each —ORIGINAL BID and —COPY OF BID, as appropriate. In the event of any discrepancy between them, the original shall govern.
	<b>16.2</b>	The original and the copy or copies of the bid shall be typed or written in indelible ink and shall be signed by the Bidder or a person or persons duly authorized to bind the Bidder to the contract. All pages of the bid, except for unamended printed literature, shall be initialled by the person or persons signing the bid.
	<b>16.3</b>	Any interlineation, erasures, or overwriting shall be valid only if they are initialled by the person or persons signing the bid.
	<b>16.4</b>	The Bidder shall furnish information as described in the Form of Bid on commissions or gratuities, if any, paid or to be paid to agents relating to this Bid, and to contract execution if the Bidder is awarded the contract.
<b>D. Submission of Bids</b>		
<b>17. Sealing and Marking Of Bids</b>	<b>17.1</b>	The Bidder shall seal the original and each copy of the bid in envelopes.
	<b>17.2</b>	The inner and outer envelopes shall:
		(a) be addressed to the Purchaser at the address given in the Bid Data Sheet; and
		(b) bear the title of procurement Activity indicated in the Bid Data Sheet, the Invitation for Bids (IFB) title and number indicated in the Bid Data Sheet, and a statement: —DO NOT OPEN BEFORE, to be completed with the time and the date specified in the Bid Data Sheet, pursuant to ITB Clause 6.3.

	<b>17.3</b>	The inner envelopes shall also indicate the name and address of the Bidder to enable the bid to be returned unopened in case it is declared —late.
	<b>17.4</b>	If the outer envelope is not sealed and marked, the Purchaser will assume no responsibility for the bid's misplacement or premature opening.
<b>18. Deadline For Submission of Bids</b>	<b>18.1</b>	Bids must be received by the Purchaser at the address specified under ITB Clause 6.2 no later than the time and date specified in the Bid Data Sheet.
	<b>18.2</b>	The Purchaser may, at its discretion, extend this deadline for the submission of bids by amending the bidding documents, in which case all rights and obligations of the Purchaser and bidders previously subject to the deadline will thereafter be subject to the deadline as extended.
<b>19. Late Bids</b>	<b>19.1</b>	Any bid received by the Purchaser officer after the deadline for submission of bids prescribed by the Purchaser will be rejected and returned unopened to the Bidder.
<b>20. Modification and Withdrawal Of Bids</b>	<b>20.1</b>	The Bidder may modify or withdraw its bid after the bid's submission, provided that written notice of the modification, including substitution or withdrawal of the bids, is received by the Purchaser prior to the deadline prescribed for submission of bids.
	<b>20.2</b>	The Bidder's modification or withdrawal notice shall be prepared, sealed, marked, and then dispatched. A withdrawal notice may also be sent by email, but followed by a signed confirmation copy, postmarked not later than the deadline for submission of bids.
	<b>20.3</b>	No Bid may be modified after the deadline for submission of bids
	<b>20.4</b>	No bid may be withdrawn in the interval between the deadline for submission of bids and the expiration of the period of bid validity specified by the Bidder on the Bid Form. Withdrawal of a bid during this interval may result in the Bidder's forfeiture of its bid security.
<b>E. Opening and Evaluation of Bids</b>		
<b>21. Opening Of Bids by the Purchaser</b>	<b>21.1</b>	The Purchaser will open all bids in the presence of bidders' representatives who choose to attend, at the time, on the date, and at the place specified in the Bid Data Sheet. The bidders' representatives who are present shall sign an attendance sheet evidencing their presence.

	<b>21.2</b>	The bidders' names, bid modifications or withdrawals, bid prices, discounts, and the presence or absence of requisite bid security and such other details as the Purchaser, at its discretion, may consider appropriate, will be announced at the opening. No bid shall be rejected at bid opening, except for late bids, which shall be returned unopened to the Bidder.
	<b>21.3</b>	Bids (and modifications sent) that are not opened and read out at bid opening shall not be considered further for evaluation, irrespective of the circumstances. Withdrawn bids will be returned unopened to the bidders. The Purchaser will prepare minutes of the bid opening.
	<b>21.4</b>	The Purchaser will prepare minutes of the bid opening.
<b>22. Clarification Of Bids</b>	<b>22.1</b>	During evaluation of the bids, the Purchaser may, at its discretion, ask the Bidder for a clarification of its bid. The request for clarification and the response shall be in writing, and no change in the prices or substance of the bid shall be sought, offered, or permitted.
<b>23. Preliminary Examination</b>	<b>23.1</b>	The Purchaser will examine the bids to determine whether they are complete, whether any computational errors have been made, whether required sureties have been furnished, whether the documents have been properly signed, and whether the bids are generally in order.
	<b>23.2</b>	Arithmetical errors will be rectified on the following basis. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail, and the total price shall be corrected. If the Supplier does not accept the correction of the errors, its bid will be rejected, and its bid security may be forfeited. If there is a discrepancy between words and figures, the amount in words will prevail.
	<b>23.3</b>	The Purchaser may waive any minor informality, nonconformity, or irregularity in a bid which does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of any Bidder.

	<b>23.4</b>	Prior to the detailed evaluation, the Purchaser will determine the substantial responsiveness of each bid to the bidding documents. For purposes of these Clauses, a substantially responsive bid is one which conforms to all the terms and conditions of the bidding documents without material deviations. The Purchaser's determination of a bid's responsiveness is to be based on the contents of the bid itself without recourse to extrinsic evidence.
	<b>23.5</b>	If a bid is not substantially responsive, it will be rejected by the Purchaser and may not subsequently be made responsive by the Bidder by correction of the nonconformity.
<b>24. Qualification &amp; Evaluation Of Bids</b>	<b>24.1</b>	In the absence of prequalification, the Purchaser will determine to its satisfaction whether the Bidder is qualified to perform the contract satisfactorily, in accordance with the criteria listed in ITB Clause 3.1 & 3.2.
	<b>24.2</b>	The determination will take into account the Bidder's financial, technical, and production capabilities. It will be based upon an examination of the documentary evidence of the Bidder's qualifications submitted by the Bidder, pursuant to ITB Clause 3.1 & 3.2, as well as such other information as the Purchaser deems necessary and appropriate.
	<b>24.3</b>	The Purchaser will <b>technically evaluate</b> and compare the bids which have been determined to be substantially responsive.
	<b>24.4</b>	The Purchaser's financial evaluation of a bid will be on delivered duty paid (DDP) price inclusive of prevailing taxes and duties.
<b>25. Alternate</b>	<b>25.1</b>	<b>Quality &amp; Cost-based Selection:</b> The following merit point system for weighing evaluation factors can be applied if specified in the Bid Data Sheet. The number of points allocated to each factor shall be specified in the Bid Data Sheet.

Contacting the Purchaser</b>	<b>26.1</b>	No Bidder shall contact the Purchaser on any matter relating to its bid, from the time of the bid opening to the time evaluation report is made public i.e. 10 days before the contract is awarded. If the Bidder wishes to bring additional information or has grievance to the notice of the Purchaser, it should do so in writing.	
	<b>26.2</b>	Any effort by a Bidder to influence the Purchaser during bid evaluation, or bid comparison may result in the rejection of the Bidder's bid.	
<b>F. Award Of Contract</b>			
<b>27. Award Criteria</b>	<b>27.1</b>	The Purchaser will award the contract to the successful Bidder whose bid has been determined to be substantially responsive and has been determined to be the lowest evaluated bid, provided further that the Bidder is determined to be qualified to perform the contract satisfactorily.	
<b>28. Purchaser's Right To Vary Quantities at Time Of Award.</b>	<b>28.1</b>	The Purchaser reserves the right at the time of contract award to increase or decrease, by the percentage indicated in the Bid Data Sheet, the quantity of goods and services originally specified in the Schedule of Requirements without any change in unit price or other terms & conditions.	
<b>29. Purchaser's Right To Accept or Reject All Bids</b>	<b>29.1</b>	The Purchaser reserves the right to accept or reject all bids, and to annul the bidding process at any time prior to contract award, without thereby incurring any liability to the Bidder or bidders or any obligation to inform the Bidder or bidders of the grounds for the Purchaser's action.	
<b>30. Notification of Award</b>	<b>30.1</b>	Prior to the expiration of the period of bid validity, the Purchaser will notify the successful Bidder in writing by registered letter or by email, to be confirmed in writing by registered letter, that its bid has been accepted.	
	<b>30.2</b>	The notification of award will constitute the formation of the Contract.

	<b>31.2</b>	Within seven (07) days of receipt of the Contract Form, the successful Bidder shall sign and date the contract and return it to the Purchaser.
<b>32. Performance Guarantee</b>	<b>32.1</b>	Within fourteen (14) days of the receipt of notification of award from the Purchaser, the successful Bidder shall furnish the Performance guarantee, in accordance with the Conditions of Contract, in the Performance guarantee Form provided in the bidding documents, or in another form acceptable to the Purchaser.
	<b>32.2</b>	The Performance Guarantee shall be returned to the supplier after successful completion of the Warranty period in true spirit.
<b>33. Corrupt Or Fraudulent Practices</b>	<b>33.1</b>	The Procuring Agency requires that Bidders, Suppliers, and Contractors observe the highest standard of ethics during the procurement and execution of contracts. For the purposes of Provision, the terms set forth below are defined as follows:
		(i) —corrupt practice means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution; and
		(ii) —fraudulent practice means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the Procuring Agency,

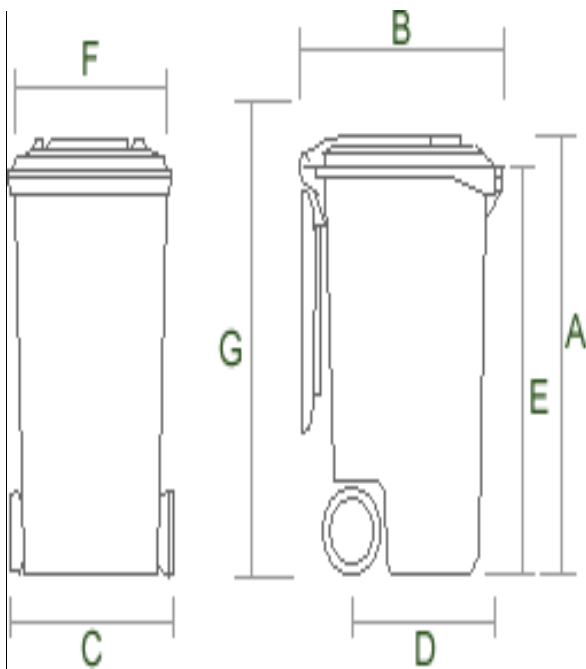

**1. Definitions** 1.1 In this Contract, the following terms shall be interpreted as indicated:

- (a) —The Contract<sup>1</sup> means the agreement entered into between the Purchaser and the Supplier, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- (b) —The Contract Price<sup>1</sup> means the price payable to the Supplier under the Contract for the full and proper performance of its contractual obligations.
- (c) —The Goods<sup>1</sup> means all of the equipment, machinery, and/or other materials which the Supplier is required to supply to the Purchaser under the Contract.
- (d) —The Services<sup>1</sup> means those services ancillary to the supply of the Goods, such as transportation and insurance, and any other incidental services, such as installation if required, commissioning, provision of technical assistance, training, and other such obligations of the Supplier covered under the Contract.
- (e) —GCC<sup>1</sup> means the General Conditions of Contract contained in this section.
- (f) —SCC<sup>1</sup> means the Special Conditions of Contract.
- (g) —The Purchaser<sup>1</sup> means the organization purchasing the Goods, as named in SCC.
- (h) —The Purchaser's country<sup>1</sup> is Islamic Republic of Pakistan.

**2. Application**

2.1 These General Conditions shall apply to the extent that they are not superseded by provisions of other parts of the Contract.

**3. Country of Origin**

3.2 For purposes of this Clause, —origin means the place where the Goods were mined, grown, or produced, or from which the Services are supplied. Goods are produced when, through manufacturing, processing, or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or Utility from its components.

3.3 The origin of Goods and Services is distinct from the nationality of the Supplier.

**4. Standards**

4.1 The Goods supplied under this Contract shall conform to the standards mentioned in the Technical Specifications, and, when no applicable standard is mentioned, to the authoritative standards appropriate to the Goods' country of origin. Such standards shall be the latest issued by the concerned institution.

**5. Use of Contract Documents and Information; Inspection and Audit by the Bank**

5.1 The Supplier shall not, without the Purchaser's prior written consent, disclose the Contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the Purchaser in connection therewith, to any person other than a person employed by the Supplier in the performance of the Contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such Performance.

11.1 The Goods supplied under the Contract shall be delivered duty paid (DDP) under which risk is transferred to the buyer after having been delivered; hence insurance coverage is seller's responsibility.

**12. Transportation**

12.1 The Supplier is required under the Contract to transport the Goods to a specified place of destination within the Purchaser's country, transport to such place of destination in the Purchaser's country, including insurance and storage, as shall be specified in the Contract, shall be arranged by the Supplier, and related costs shall be included in the Contract Price.

**13. Incidental Services**

13.1 The Supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:

- (a) performance or supervision of on-site assembly and/or start-up of the supplied Goods;
- (b) furnishing of tools required for assembly and/or maintenance of the supplied Goods;
- (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied Goods;

- (d) performance or supervision or maintenance and/or repair of the supplied Goods, for a period of time agreed by the parties, provided that this service shall not relieve the Supplier of any warranty obligations under this Contract; and
- (e) Training of the Purchaser's personnel, at the Supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied Goods.

13.2 Prices charged by the Supplier for incidental services, if not included in the Contract Price for the Goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged for other parties by the Supplier for similar services.

**14. Spare Parts**

14.1 As specified in SCC, the Supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the Supplier:

- (a) such spare parts as the Purchaser may elect to purchase from the Supplier, provided that this election shall not relieve the Supplier of any warranty obligations under the Contract; and
- (b) in the event of termination of production of the spare parts:

including insurance and storage, as shall be specified in the Contract, shall be arranged by the Supplier, and related costs shall be included in the Contract Price.

**15. Warranty**

15.1 The Supplier warrants that the Goods supplied under the Contract are new, unused, of the most recent or current models and those they incorporate all recent improvements in design and materials unless provided otherwise in the Contract. The Supplier further warrants that all Goods supplied under this Contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the Purchaser's specifications) or from any act or omission of the Supplier, that may develop under normal use of the supplied Goods in the conditions prevailing in the country of final destination.

15.2 This warranty shall remain valid for twelve (12) months after the Goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the Contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.

15.3 The Purchaser shall promptly notify the Supplier in writing of any claims arising under this warranty.

15.4 Upon receipt of such notice, the Supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective Goods or parts thereof, without costs to the Purchaser.

15.5 If the Supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, within a reasonable period, the Purchaser may proceed to take such remedial action as may be necessary, at the Supplier's risk and expense and without prejudice to any other rights which the Purchaser may have against the Supplier under the Contract.

**16. Payment**

16.1 The method and conditions of payment to be made to the Supplier under this Contract shall be specified in SCC.

17. 16.2 The Supplier's request(s) for payment shall be made to Purchaser in writing, accompanied by an invoice describing, as Appropriate, the Goods delivered and Services performed, and by documents submitted pursuant to GCC Clause 10, and upon fulfilment of other obligations stipulated in the Contract.

16.3 Payments shall be made promptly by the Purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the Supplier.

16.4 The currency of payment is Pak. Rupees.

**17. Prices**

17.1 Prices charged by the Supplier for Goods delivered and Services performed under the Contract shall not vary from the prices quoted by the Supplier in its bid, with the exception of any price adjustments authorized in SCC or in the Purchaser's request for bid validity extension, as the case may be.

**18. Change Orders**

18.1 The Purchaser may at any time, by a written order given to the Supplier pursuant to GCC Clause 31, make changes within the general scope of the Contract in any one or more of the following:

- (a) drawings, designs, or specifications, where Goods to be furnished under the Contract are to be specifically manufactured for the Purchaser;
- (b) the method of shipment or packing;
- (c) the place of delivery; and/or
- (d) the Services to be provided by the Supplier.

18.2 If any such change causes an increase or decrease in the cost of, or the time required for, the Supplier's performance of any provisions under the Contract, an equitable adjustment shall be made in the Contract Price or delivery schedule, or both, and the Contract shall accordingly be amended. Any claims by the Supplier for adjustment under this clause must be asserted within thirty (30) days from the date of the Supplier's receipt of the Purchaser's change order.

**19. Contract  
 Amendments**

19.1 Subject to GCC Clause 18, no variation in or modification of the terms of the Contract shall be made except by written amendment signed by the parties.

- 20. Assignment** 20.1 The Supplier shall not assign, in whole or in part, its obligations to perform under this Contract, except with the Purchaser's prior written consent.
- 21. Subcontracts** 21.1 The Supplier shall notify the Purchaser in writing of all subcontracts awarded under this Contract if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the Supplier from any liability or obligation under the Contract.
- 21.2 Subcontracts must comply with the provisions of GCC Clause 3.
- 22. Delays in the Supplier's Performance** 22.1 Delivery of the Goods and performance of Services shall be made by the Supplier in accordance with the time schedule prescribed by the Purchaser in the Schedule of Requirements.
- 22.2 If at any time during performance of the Contract, the Supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the Goods and performance of Services, the Supplier shall promptly notify the Purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the Supplier's notice, the Purchaser shall evaluate the situation and may at its discretion extend the Supplier's time for performance, with or without liquidated damages, in which case the extension shall be ratified by the parties by amendment of Contract.
- 22.3 Except as provided under GCC Clause 25, a delay by the Supplier in the performance of its delivery obligations shall render the Supplier liable to the imposition of liquidated damages pursuant to GCC Clause 23, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of liquidated damages.
- 23. Liquidated Damages** 23.1 Subject to GCC Clause 25, if the Supplier fails to deliver any or all of the Goods or to perform the Services within the period(s) specified in the Contract, the Purchaser shall, without prejudice to its other remedies under the Contract, deduct from the Contract Price, as liquidated damages, a sum equivalent to the percentage specified in SCC of the delivered price of the delayed

Goods or unperformed Services for each week or part thereof of delay until actual delivery or performance, up to a maximum deduction of the percentage specified in SCC. Once the maximum is reached, the Purchaser may consider termination of the Contract pursuant to GCC Clause 24.

**24. Termination**  
**Default**

24.1 The Purchaser, without prejudice to any other remedy for breach of Contract, by written notice of default sent to the Supplier, may terminate this Contract in whole or in part:

- (a) if the Supplier fails to deliver any or all of the Goods within the period(s) specified in the Contract, or within any extension thereof granted by the Purchaser pursuant to GCC Clause 22; or
- (b) if the Supplier fails to perform any other obligation(s) under the Contract.
- (c) if the Supplier, in the judgment of the Purchaser has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.

For the purpose of this clause:

—corrupt practice<sup>l</sup> means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.

—fraudulent practice<sup>l</sup> means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the Procuring Agency, and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the Procuring Agency of the benefits of free and open competition.

24.2 In the event the Purchaser terminates the Contract in whole or in part, pursuant to GCC Clause 24.1, the Purchaser may procure, upon such terms and in such manner as it deems appropriate, Goods or Services similar to those undelivered, and the Supplier shall be liable to the Purchaser for any excess costs for such similar Goods or Services.

However, the Supplier shall continue performance of the Contract to the extent not terminated.

**25. Force Majeure** 25.1 Notwithstanding the provisions of GCC Clauses 22, 23, and 24, the Supplier shall not be liable for forfeiture of its performance guarantee, liquidated damages, or termination for default if and to the extent that its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

25.2 For purposes of this clause, —Force Majeure<sup>1</sup> means an event beyond the control of the Supplier and not involving the Supplier’s fault or negligence and not foreseeable. Such events may include, but are not restricted to, acts of the Purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions, and freight embargoes.

If a Force Majeure situation arises, the Supplier shall promptly notify the Purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

**26. Termination for Insolvency** 26.1 The Purchaser may at any time terminate the Contract by giving written notice to the Supplier if the Supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the Supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the Purchaser.

The notice of termination shall specify that termination is for the Purchaser's convenience, the extent to which performance of the Supplier under the Contract is terminated, and the date upon which such termination becomes effective.

27.2 The Goods that are complete and ready for shipment within thirty (30) days after the Supplier's receipt of notice of termination shall be accepted by the Purchaser at the Contract terms and prices. For the remaining Goods, the Purchaser may elect:

- (a) to have any portion completed and delivered at the Contract terms and prices; and/or
- (b) to cancel the remainder and pay to the Supplier an agreed amount for partially completed Goods and Services and for materials and parts previously procured by the Supplier.

**28. Resolution of  
Disputes**

28.1 The Purchaser and the Supplier shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the Contract.

28.2 If, after thirty (30) days from the commencement of such informal negotiations, the Purchaser and the Supplier have been unable to resolve amicably a Contract dispute, either party may require that the dispute be referred for resolution to the formal mechanisms specified in SCC. These mechanisms may include, but are not restricted to, conciliation mediated by a third party, adjudication in an agreed and/or arbitration.

**29. Governing  
Language**

29.1 The Contract shall be written in the language specified in SCC. Subject to GCC Clause 30, the version of the Contract written in the specified language shall govern its interpretation. All correspondence and other documents pertaining to the Contract which are exchanged by the parties shall be written in the same language

**31. Notices**

31.2 A notice shall be effective when delivered or on the notice's effective date, whichever is later.

**32. Taxes and  
Duties**

32.1 Supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted Goods to the Purchaser.

#### **2. Country of Origin (GCC Clause 3)**

#### **3. Performance Guarantee (GCC Clause 7)**

GCC 7.1—The amount of performance guarantee, as a percentage of the Contract Price, shall be 2% (Two per cent of the contract price) in the shape of non-recourse, irrevocable and unconditional bank guarantee from scheduled bank of Pakistan on the prescribed format attached with the bidding document.

- (c) Replacement of the whole unit at site including transportation, installation, testing & commissioning etc in case of major defect at his own cost.
